**Subject:** PICIS update 12/16/2012: Grandfathered PA Report is ready to review

Dear Providers,

The Grandfathered PA (GPA) report is available for you to view in PICIS. Once in PICIS, please click on "REPORTS", then "AUTHORIZATIONS", then click on "Grandfathered Prior Authorizations". Once you have the report on the screen, please review the cover page for a description and instruction. Due to the large amount of information on the report, it will not be possible to print without first exporting to Excel.

Why is this report important? This report will show you what authorization level you will receive for active customers. If inaccuracies exist, it is important that they are corrected before 1/15/2013. After that date, you will be required to complete paperwork to correct any inaccurate GPAs. Please note that the GPA process is not at the moment an automated process. We will do updates periodically, but hope to have a nightly process soon.

The current report is still being enhanced. If you have any suggestions on format, please send them to Kate Davis at [KMDavis@odmhsas.org](mailto:KMDavis@odmhsas.org). This week you will see two new reports which will separate those which did receive a GPA and those which did not. Please check the first for accuracy and the second to correct any existing problems.

Below is a list of the possible reasons why active customers were and were not grandfathered. This is for all 736 providers, not just your customers. Once you access your report, scroll to the right and you will see the reasons. If they are correctable by you, please do so. If not, please email me and I will assist. 283 - Rules for SA Residential Treatment have changed. Current CDC will not create authorization past 1/15/2013.

250 - Current Day Treatment Authorization will not extend past 1/15/2013

180 - Current Detox CDC will not create authorization past 1/15/2013.
