# TEMPORARY LIFT OF OUTPATIENT PA's, including Drug Court

---

- For all outpatient behavioral health services, the prior authorization requirement has been **temporarily** lifted for the dates of service 9/26/11 forward.
- This includes:
  - ODMHSAS Substance Abuse Residential Treatment
  - ODMHSAS Substance Abuse Detox
  - ODMHSAS Substance Abuse Halfway House
  - ODMHSAS Mental Health Enhanced Residential Treatment
  - ODMHSAS Mental Health ResCare
  - ODMHSAS MH Crisis Units and ODMHSAS Inpatient
  - And Day School, Med Clinic, Prison-related, Clubhouse, Day Center, Housing, Mobile Crisis, PACT, SOC

# NEED TO RESUBMIT UNPAID CLAIMS

---

- Starting DECEMBER 5<sup>th</sup>, BUT NOT BEFORE, submit any unpaid claims for the dates of service of 9/26/11 forward.
- Reminder: Medical necessity criteria still apply and providers are subject to post payment review.

# RECOUP OF ADVANCE PAYMENTS

---

- If you received an advanced payment, OHCA will begin recouping all advance payments on the Dec. 14<sup>th</sup> remit.
- OHCA will recoup 25% of the advancement on Dec 14<sup>th</sup> and then 25% on each subsequent remit. In the event that the original remit is less than 25% of the advancement, OHCA will recoup the entire payment.

# TEMPORARILY, CDC FORMS WILL NOT BE REQUIRED FOR PAYMENT

- Once the process for submittal is reestablished, the agency will require that providers submit an active Client Data Care (CDC) form.
- At which point, the CDC form will no longer be a condition for prior authorization, but will be a condition for payment. Details on when and how the CDC form will be submitted will be forthcoming in future communications with contracted providers.
- **YOU MUST CONTINUE TO COLLECT CDC DATA AND BE PREPARED TO REPORT IT!**

# PSYCHIATRIC INPATIENT PA PROCESS IN THE SHORT TERM REMAINS THE SAME

---

- Until Jan. 3, the plan is for Optum Health to continue to service all inpatient prior authorizations, care coordination, psychiatric consultation services and medication review/authorization.
- **BEGINNING JAN. 3, 2012** OHCA will assume the responsibility for telephonic review/prior authorization of all inpatient services (acute & residential) and therapeutic foster care. Specifics are being determined presently and details will follow.

- Moving forward, OHCA will be addressing its needs and desires for a future payment system with regards to inpatient and outpatient behavioral health claims. Input from providers and other stakeholders will be solicited and appreciated.
