

4th Annual Charles P. Seger Seminar on Depression

Friday, May 14, 2004 8:30 a.m. to 12:30 p.m.

Program Purpose

The Mental Health Association in Tulsa and the Oklahoma Department of Mental Health and Substance Abuse Services invite you to the 4th Annual Charles P. Seger Seminar on Depression. The purpose of this half-day seminar is to explore the impact suicide has on individuals, family members, and the community at large. Presenters will be discussing best practices for the treatment of depression and for suicide intervention. The workshop will focus on the myths that surround suicide, the ethical and religious aspects of suicide, the latest research on suicide, and how research data can be translated into improved prevention and treatment initiatives. The seminar fee will be waived for consumers, family members, and the general public. Mental Health, Substance Abuse, and Domestic Violence professionals will be charged a \$35 fee. **Seating will be limited so pre-registration is required.**

Program Objectives

Upon completion of the program, the participant shall be able to:

1. Discuss the myths surrounding suicide along with the ethical and religious aspects.
2. Recite the latest research on suicide.
3. Identify ways in which research data can be used to improve suicide prevention and create more effective treatment options.

Continuing Education Credits

The Oklahoma Department of Mental Health and Substance Abuse Services, Institute for Mental Health and Substance Abuse Education and Training, is accredited by the Oklahoma State Medical Association (OSMA) Council on Medical Education to sponsor continuing medical education for physicians.

The DMHSAS Institute for Mental Health and Substance Abuse Education and Training has applied for 3.5 credit hours in Category I of the Physician's Recognition Award of the American Medical Association for this medical education activity.

Continuing education credit hours have been applied for through the Oklahoma State Board of Licensed Social Workers and Licensed Behavioral Practitioners Board. Credit hours have been approved by the Oklahoma Board of Examiners of Psychologists and the Licensed Professional Counselors Committee.

Certificates of attendance will be distributed at the end of the seminar. Faculty

Gerard P. Clancy, M.D. is the Dean of the OU College of Medicine in Tulsa and a Professor in the Department of Psychiatry. Dr. Clancy completed medical school and residency at the University of Iowa College of Medicine where he returned after serving as a flight surgeon in the Air Force. While at the University of Iowa Dr. Clancy was the Assistant Dean for the Office of Student Affairs, Medical Director for Behavioral Health of Students, Vice Chair of the Department of Psychiatry, and Associate Professor of Psychiatry. Much of his career has focused on the development and implementation of clinical and educational programs and a number of projects providing outreach behavioral services to the seriously mentally ill. Dr. Clancy received the Excellence in Community Psychiatry Award for 2002 given by the National Alliance for the Mentally Ill for his work in introducing the Program of Assertive Community Treatment (PACT) while in Iowa.

Tony Reantaso, M.D. is an Assistant Professor of Psychiatry and the Director of the new Program for Assertive Community Treatment (PACT) at the OU College of Medicine, Tulsa. He oversees the development of PACT in Tulsa, funded by the Oklahoma Department of Mental Health and Substance Abuse Services. Prior to Reantaso's appointment to OU, he served as a psychiatrist with Traditions Behavioral Health, a corporation providing contractual mental health services for the Telecare Corporation in Southern California and other multi-state regions. Reantaso earned his medical degree from the University of Santo Tomas Faculty of Medicine and Surgery, Manila, Philippines, and completed his residency at the University of Oklahoma College of Medicine, Tulsa, where he served as chief resident. He is a member of the American Medical Association and American Psychiatric Association.

Nancy Brahm, MS, Pharm.D., B.C.P.P. holds undergraduate degrees in pharmacy and psychology. She studied clinical psychology and statistics at the graduate level before obtaining her Master of Science degree in Health Administration and completing her doctorate in pharmacy. Brahm, a clinical Assistant Professor in the College of Pharmacy, OU-Tulsa, is board certified in psychiatric pharmacy. She has provided clinical pharmacology services to the developmentally disabled in Oklahoma since 1995, and has lectured extensively in this area.

Kevin Donovan, M.D., M.L.A. is a Professor at the OU College of Medicine-Tulsa and founder and Director of the Oklahoma Bioethics Center. He received his undergraduate degree from Notre Dame, and his MD and Master's, in Bioethics from the University of Oklahoma, where he has been a faculty member for over 20 years. He has been a visiting scholar at the Kennedy Institute of Ethics in Washington, D.C., serves on the national Committee on Bioethics for the American Academy of Pediatrics, and either chairs or serves on Ethics Consultation committees for St Francis Hospital, St John Medical Center, and Hillcrest hospital in Tulsa. Dr. Donovan is a recipient of the Humanism in Medicine Award, recognizing physicians who integrate humanism into care of patients and their families.
