Admission: Individual begins an outpatient treatment episode.

Discharge: Individual leaves outpatient treatment at that agency.

All Mental Health Contract Sources: Includes the following contract sources: 01, 24, 25, 32, 39, 42, 43, 45, 47, 48, 50, 53, 55, 56, 57, 58, and 59).

Age Group: For active individuals, age is calculate at the end of the time period. For discharged individuals, age is calculated at discharge.

What is excluded from the analysis:

1. Non-outpatient services/individuals
2. Crisis Services
3. Persons discharged within three months of admission.
4. Persons with less than three non-crisis services.
